- 7) To help the poor, orphans, physically and mentally handicapped people, widows and other disable persons, by providing monetary or any other kind of assistance either by payment in cash or in kind, supply or cloths, food, shelter medical facilities and the like at a concessional rate or otherwise.
- 8) To provide various schemes for promotions of self employment for the weaker sections of the society or needy.
- 9) To give encouragement and to start centers for the promotion of education of Veda, puranas, shastras and other allied Sanskrit Literature of ancient lore.
- 10) To establish and/or conduct hospitals dispensaries or medical clinics, schools, colleges, training institutes etc.,.
- 11) To equip all. any institutions, hospitals, schools, colleges and public homes with all necessary paraphernalia, sophisticated gadgets and instruments and all other things required;
- 12) To provide quality education and to provide accommodation facilities for students who are in need, help students to get scholarships and to encourage poor/ backward class/ weaker section students by giving medals and other financial assistance.
- 13) To establish take over, maintain and run the schools, residential schools, colleges or any other educational institutions and to promote the education, science, technology arts, commerce and various other faculties.
- 14) To promote charity, sports, culture, philosophies.
