- m) To run old-age homes and day care centre for old people who are poor.
- n) To help alcoholics in de-addiction.
- o) To run hospitals and free dispensaries for the poor.
- p) To provide relief to poor HIV positive and AIDS patients.
- q) To create awareness and to take steps to prevent female infanticide.
- r) To work for rehabilitation of rag-pickers and street urchins.
- s) To conduct awareness programmes for empowerment of rural women.
- t) To help poor and needy youth to be self-employed by providing them with skills, training and finance.
- u) To carry on relief operations and help the public during natural calamities like draught, flood, earthquake, tsunami and other acts of God.
- v) To conduct awareness programs for environment protection and pollution control.
- w) To conduct activities to protect the environment.
- x) All these objects of the trust will be made available to everybody irrespective of caste, creed, religion and sex.
- y) It is made clear that all the objects of the trust shall be charitable in nature.
- z) All the above objectives shall be carried out in India only.

- aa) All the funds and income of the trust shall be utilized solely towards the objectives of the trust only and no part of the income shall be distributed to the trustees or persons mentioned in section 13(1) (c) of the Income Tax Act 1961.

4. THE INCIDENTAL AND ANCILLARY OBJECTIVES OF THE TRUST ARE:

- a) To acquire, purchase, hire, sell or lease any movable or immovable property to further the objectives of the Trust. No immovable property shall be alienated without the prior approval of the commissioner of Income Tax (Exemptions)
- b) To invest the monies of the Trust not immediately required in such investments as may be permitted by the Section 11(5) read with Sec.13 (1) (d), to be decided by the Trustees.
- c) To draw, make, accept, endorse, and negotiate cheques in pursuance of the objects of the Trust.
- d) To borrow or raise funds either by loan or otherwise against the security of any immovable property of the trust, to further the objectives of the trust.
- e) To pay out of the funds of the Trust all expenses, incidental to the formation and management of the Trust.
- f) To subscribe or donate for needy, charitable, benevolent and such other objectives involving public interest.
- g) To raise donations, contributions or grants either from India or abroad from any person, company, trust, society, institution, place of worship and or Government.
- h) To do generally such other acts, matters or things, as may be necessary incidental or ancillary to all or any of the objectives mentioned above.
- i) To receive, hold and disperse funds to promote the objectives of the Trust.
- j) To register the trust under the Foreign Contribution Regulation Act.

5. CONSTITUTION OF THE BOARD OF TRUSTEES:

- a) The Board of Trustees shall consist of not less than four persons and not more than seven persons.

c) **Mr. VINUTH W GIDEON** shall be the Managing Trustee for life.

d) **Mrs. EVANGELIN RACHEL P** shall be the Treasurer for life

e) **Ms. EVANGELIN HEPSIBHA** shall be the trustee. She shall hold office for a term of two years. At the end of the term, she shall be eligible for re-appointment

f) In case of any vacancy arising on account of death, retirement and resignation or otherwise, the surviving or remaining trustee or trustees as the case may be shall have full powers to constitute and represent the board of trustees for the time being

g) On the death of the founder the Managing Trustee at that point of time or if the Author was the Managing Trustee, his successor in office shall be considered to be the Author of the trust, who shall be eligible to present and register any supplementary deed of trust to being into effect any changes in any of the clause of the trust

6. REMOVAL OF TRUSTEES:

a) Any Trustee may be removed by the Board of Trustees for breach of trust or misconduct.

b) Any Trustee desirous of retiring or resigning from the trusteeship shall be entitled to do so after giving one clear calendar month's notice in writing to the remaining trustees.

c) In case of any vacancy in the Board of Trustees arising on account of death, retirement, and resignation or otherwise of any trustee, the surviving or remaining trustee or trustees as the case may be shall have full powers to constitute and represent the Board of Trustees for the time being Subsequently the surviving or remaining trustees shall co-opt any other person as trustee to fill the vacancy.

- d) In the case of vacancy arising in the office of Managing Trustee on account of death, retirement, resignation and dissolution or otherwise the remaining trustees shall first co-opt another trustee to fill the vacancy of trustee and subsequently elect one person among the trustees as the Managing Trustee.

7. POWER OF BOARD OF THE TRUSTEES:

The board of trustees shall have powers of absolute management of all affairs, activities, and business of the trust. The Managing Trustee shall duly carry out all the decisions made by the Board of Trustees. Without limiting or in any way restricting the generality of their powers, the Board of Trustees shall exercise the following powers:

- a) The Trustees shall pay, expend, apply or utilize the trust fund and all the additions and accretion thereto from time to time or any such part thereof as they shall in their discretion decide for all or any one or more of the objects aforesaid exclusively and not for purposes of profit. No part of the income or corpus of the fund shall be utilized for any object or purpose other than those of the activities of the Trust subject to payment of tax if any.
- b) It shall be lawful for the Board of Trustees to frame rules and regulations for the conduct and management of the Trust.
- c) The Board of Trustees shall determine, from time to time the amount it shall spend on the different aspects
- d) The Board of Trustees shall have power to invest the Corpus or the income from the Trust Fund at their discretion in such investments as may be permitted under the Income- Tax law, in force, from time to time.
- e) The Board of Trustees shall open an account or accounts with any scheduled bank or banks in the name of the trust and all such bank accounts shall be operated by the Managing Trustee along with Treasurer of the Trust jointly.
- f) To institute, conduct, defend, intervene in or compromise legal proceedings by or against the Trust.
- g) To appoint committees or sub/committees from among the trustees for looking after the affairs, activities and projects of the Trust

8. MEETING OF THE BOARD OF TRUSTEES:

- a) The trustees shall meet as many times as may be considered expedient.

- b) However, before the expiry of six months from the end of every financial year the trustees shall meet to adopt the statement of accounts for the financial year and shall appoint a Chartered Accountant to audit the accounts of the Trust.
- c) The Meetings shall be convened by the Managing Trustee or in the absence of a Managing Trustee due to death or resignation, any other trustee after giving due notice, in writing, to all the trustees of 7 clear days.
- d) All meetings shall be conducted by issuing three-day notice
- e) The Managing Trustee shall maintain minutes of all meetings.
- f) The Board shall transact only business that may be specified in the agendas or any other matter that may be brought up with the permission of the chair.
- g) The Managing Trustee shall preside over all the meetings of the board.
- h) Unless otherwise provided herein, all decisions shall be carried by a simple majority that may be specified in the agenda or any other matter that may be brought up with the permission of the chair.
- i) Any resolution in writing circulated to all the Trustees and accepted and signed by a simple majority of the Trustees in token of their said acceptance shall be valid and binding on the Board of Trustees as though they said resolution had been passed at a duly convened meeting of the Board of Trustees.

09. PROPERTY OF THE TRUST:

- a) All the properties of the Trust as and when acquired whether movable or immovable shall at all time be registered in the name of the Trust.
- b) All funds of the Trust, as and when acquired shall be invested in such manner as may be approved by section 13(1) (d) read with section 11(5) of the Income Tax Act, 1961.
- c) At present the trust does not have any immovable or movable properties other then the corpus fund of Rs. 1000/-
- d) However, no part of the property of the Trust shall be sold or alienated without prior permission of Commissioner of Income Tax (Exemptions).

10. FINANCIAL YEAR:

The Financial year of the trust shall be from the 1st April to the 31st March of the following year and regular accounts shall be maintained in the normal course, accordingly.

11. ACCOUNTS AND AUDIT:

The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statements of account and the Auditor's report thereon shall be placed before the Board of Trustees for its approval and adoption within three months from the close of the financial year.

12. AMENDMENTS:

- a) This trust shall be irrevocable.
- b) In case of Amendment to the objects of the trust, which changes the character of the trust, the trust shall apply for fresh registration U/s 12AB of the Income Tax Act within 30 days after the amendments have been registered

13. ALIENATION:

No Immovable property of the trust shall be alienated without the prior approval of the commissioner of Income Tax (Exemption)

14. WINDING UP:

- a) If the Trustees decide that no useful purpose will be achieved by the continuation of the Trust, it shall be open to the Trustees to dissolve and wind up the Trust.
- b) In the event of such dissolution or winding up of the Trust, the assets and properties of the Trust or any part thereof shall not be appropriated by or distributed among the Trustees or the staff of the Trust or their relatives.
- c) In such event of dissolution or winding up of the Trust, the assets and properties or any valuable part there of shall be disbursed transferred and assigned to another Trust that has similar objects and registered under the Income Tax Act under Section 12AB and 80 G.
