ORDER

This Ministry vide Notification No. AG-15039/55/2024-Sr.C-II dated 01.07.2024 invited applications from eligible organizations for gap districts for running projects under Integrated Programme for Senior Citizens (IPSrC) [a scheme under Atal Vayo Abhudyay Yojana (AVYAY)] for the Financial Year 2024-25.

2. As per the scheme guidelines, applications received from the organizations are assessed and Implementing agencies are finalized by the Screening Committee constituted in this Department. The said finalization of an Implementing Agency for a project shall be on the basis of recommendation by the Selection Committee at the respective State/UT level. In response to the Notification referred above and on the basis of recommendations received from State Government and UTs, earlier orders selecting new projects were issued on 21.01.2025 and 22.04.2025

3. In response to the above Notification, further recommendations have been received from 07 States (Goa, Jharkhand, Maharashtra, Odisha, Tamil Nadu, Telangana and Uttar Pradesh.) Therefore, the following organizations have been finalized as implementing agencies under IPSrC for financial year 2024-25: -
