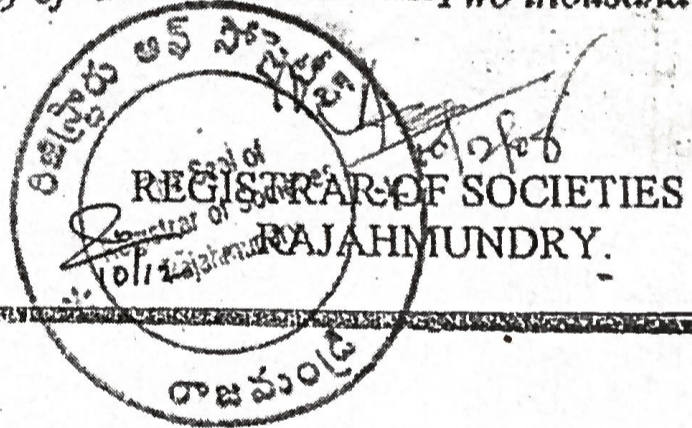

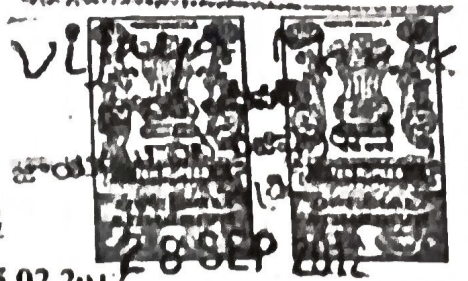

ANNUAL REPORT FOR THE YEAR 2023-2025

Sangeetha Sri Vidya Vaidya Women Welfare Society (SSVWWS) is a registered Service voluntary organization, established in 2008, under the provisions of Societies Registration Act 35 of 2001 with Regd. No. 765/2008. The organization was formed with co-operation of dedicated Social workers and enthusiastic service minded group with a view to help the helpless rural poor community through various development activities. The birth of "Sangeetha Sri Vidya Vaidya Women Welfare Society" is a response in deed an emotional response to the problems of Socio-economic, Education and Health aspects that widely prevalent in two backward Revenue Mandals of East Godavari District. Hence, the organization formed with no profit motive and dedicated to solve the identified programmes. The following are activities took up by our organization during the year 2023-2025

1. Vocational Training Programme :

The main objective of this programme is to provide Institutional services to unemployed women, youth, needy and women below the poverty line through vocational guidance, traditional and Income generating training programs to attain self sufficiency. Sangeetha Sri Vidya Vaidya Women Welfare Society providing Vocational Training to women and youth of below poverty line in job oriented Tailoring & Embroidery Training, more than 100 candidates and enemployed youth benefited through this programme.

2. Medical Camps :

Sangeetha Sri Vidya Vaidya Women Welfare Society conducted medical camps on community health, education, Pulse polio, Hepatitis-B and General health problems and also conducted free medical checkup camps and distributed medicines to the Patients.

3. Self Help groups awareness:

Our organization has encouraged Thrift and credit habit among the poor women and made them as a Medisetti Lakshmi groups in our area. During the Year we motivated women and farm them as 20 SHG's and move forward them to take up women development activities. Now they are starting internal lending among the members of the group. It resulted to reduce the

dependency on private money lenders with a higher rate of interest. It also helped to the poor women to increase their confidence to work their development as Group.

4. NREGS awareness camps :

As an organization motivated / educated people at village about national rural Employment Guarantee Scheme to get compulsory employment through the Programme. In that camps our NGO educated people that how to get job card, wages, working days, payment schedules etc. to increase people's income to add their family needs.

5. HIV/AIDS:

To bring awareness about the prevention HIV/AIDS among public our organization has organize awareness camps at 8 Villages and conducted rallies, posters, pamphlets and campaigns. Our organization established SHGs, V.O.s and M.O.s actively participated in all awareness camps and rallies. A part from this our organizers / programme staff had actively participated in highlighting the prevention of HIV/AIDS in our area by organizing various village level as well as Mandal Level meetings.

6. Dropout & Child labour awareness camps Survey :

As an organization we conducted child labour awareness and survey camps in 3 mandals to eradicate the child labour at the areas. We educated parents about the importance of children education for future building. In this aspect we conducted 6 child labour awareness camps, total 220 parents participated and 48 children are joined in mainstream through out the year.

7. Community Organisation :

According to the captioned project women & youth oriented Community Development Programme (Period 2009-2012) In this aspect our organization Sangeetha Sri Vidya Vaidya Women Welfare Society established women and youth groups in 75 villages. And capacity building, leadership activities conducted in all 75 villages. Network promotion activities had been conducted i.e., establishment of village organizations as well as Mandal organizations to collective development activities.

8. Family counseling centres cases :

As an organization we take up 70 cases by our family counseling programmes. 37 cases solved by our family centres.

9. Adult Education Programme :

As an organization we conducted 6 Adult education centers at the area and 124 people are literated through the centers. The system of Adult education centers conducted with non formal techniques. The people at the area now coming forward to write and read.

10. Pulse Polio Camp :

Our organizers actively participated in Pulse Polio Immunization campaign at our area our organizers regularly close watching health activities to prevention of false traditional health systems. As result 98% immunization has taken place in our target villages.

11. Leadership Training :

As on organization we motivated youth and conducted youth leadership training programmes to development schemes like PMRY, RYS etc to set-up their employment to created their economic base for future.

12. Drinking Water Awareness camps :

To bring awareness about the prevention of water content viral diseases by fortifying drinking water. Our organization has organize awareness camps at 6 village and conducted rallies, Posters, Pamphlets and campaigns. Our organization established SHGs, V.O.S., M.O., actively participated in all awareness camps, and rallies. A part from this our organizers / programme staff had actively participated in highlighting the importance of drinking water in our project area by organizing various village level meetings.
